2. 6. **Generic**

Bidders shall quote only those products (Part of Service delivery) in the bid which are not obsolete in the market and has at least 1 years residual market life i.e. the offered product shall not be declared end-of-life by the OEM before this period.

7. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

8. **Service & Support**

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

9. **Service & Support**

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

10. **Generic**

Consortium: In case of Contracts, wherein the seller alone does not have necessary expertise, the seller can form consortium with other sellers for submission of the bid, with one of the consortium company as leader. However, each and every member of the consortium shall be equally responsible for the complete execution of the project contract. An undertaking to this effect is to be uploaded with bid.

11. **Generic**

8. **Experience - No. of years in the Business:**

The Bidder should be in the Business of Providing "Similar Service" for a period not less than 5 years i.e. since 2020 - 2025.

[Mode of Proof: Copies of the Work order/Contract Agreement or Work Completion certificate for the Completed work - Proof for existence during or prior to 2020 - 2025].

9. **Turnover:: Average annual turnover should not be less than Rs. 1 crore during the past 3 financial years i.e. 2022-23, 2023-24 & 2024-25.[Mode of Proof: Annual accounts duly certified by a Chartered Accountant].**
10. B. Evaluation Criteria of Financial Bid:

1. The bidder must bid for all the packages and all item in each of the package . In case bidder has submitted bid for few item in a package or not bided for all the packages then bid will be rejected i.e. partial bid is not acceptable.
2. Bidders are informed to refer Price Bid format before quoting Final total Price in GeM step by step as follows:
 - 2.1. The vendors are required to fill the attached Price bid format w.r.t. the rates of individual items of mentioned Packages (A, B, C & D).
 - 2.2. Total of Package (A+B+C+D) is to be filled in the GeM financial bid.
3. Rates must be **inclusive of all taxes** .
4. No conditional pricing will be accepted.
5. Prices shall be quoted in **INR** only.
6. "Price Bid shall be submitted **online in the attached format along with the GeM Financial Bid.**"
7. Modifying the attached Price Bid Format structure is strictly prohibited."

The Purchase committee has the right to seek details about the viability of the quote in case the rates are seen to be very low. Quotes with unworkable rates will not be considered and such bids are liable to be rejected. The decision of the Purchase Committee in this regard will be final and no further correspondence will be entertained.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove;**

and

- All operative provisions of the erstwhile Labour Laws until their complete substitution.

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
